

JITR PRIVACY POLICY

JITR Inc. ("JITR") takes your privacy seriously. Please read the following to learn more about our privacy policy

What this Privacy Policy Covers

- * This Privacy Policy covers JITR's treatment of the personally identifiable information that JITR collects when you use JITR's services. This policy also covers JITR's treatment of any personally identifiable information that JITR's business partners share with JITR.
- * This policy does not apply to the practices of companies that JITR does not own or control, or to people that JITR does not employ or manage, including without limitation, any JITR affiliates or business partners.

Information Collection and Use

- * JITR collects personally identifiable information when you register for a JITR account, when you use certain JITR products or services, and when you enter promotions or sweepstakes. JITR may also receive personally identifiable information from our business partners.
- * When you register with JITR, we ask for your name, email address, and other identifiable information. Once you register with JITR and sign in to our services, you are not anonymous to us.
- * JITR also automatically receives and records information on our server logs from your browser including your IP address, and the content items you requested.
- * JITR uses information for the following general purposes: to customize the content you see on our pages, to fulfill your requests for certain products and services, improve our services, conduct research, and to contact you about specials and new products or for service announcements or administrative messages relating to the JITR service.

Information Sharing and Disclosure

- * JITR will not sell or rent your personally identifiable information to anyone.
- * JITR will not share personally identifiable information about you to other companies or people unless:
 - We have your consent to share this information;
 - We need to share your information to provide the product or service you have requested;
 - We need to share the information with companies who work on behalf of JITR to provide a product or service to you. Please know that whenever we share your personal information with these trusted business partners, they work under confidentiality agreements. (Unless we tell you differently, these companies do not have any right to use the personally identifiable information we provide to them beyond what is necessary to assist us);
 - We reasonably believe it is necessary to share information in order to investigate, prevent,

or take action regarding illegal activities, situations involving potential threats to the physical safety of any person, or as otherwise required or permitted by law;

- We respond to warrants, subpoenas, court orders or legal process or to establish or exercise our legal rights or defend against legal claims; or

- We find that your actions on our sites violate the JITR Terms of Service or any of our usage guidelines for specific products or services. We may transfer information about you if JITR is acquired by or merged with another company. In this event, JITR will notify you before information about you is transferred and becomes subject to a different privacy policy.

Your Ability to Edit and Delete Your Account Information and Preferences

- You have the right to access, verify and update your JITR Account Information and preferences at any time.

Confidentiality and Security

* We limit access to personal information about you to employees who, as part of their job, we believe need to come into contact with that information to provide products or services to you. * We have physical, electronic, and procedural safeguards to protect personal information about you.

* In the event that you believe that your personal safety is at risk or if you believe that you may be the victim of identity theft or other illegal conduct, please contact the appropriate federal, provincial or local law enforcement agencies directly.
